HLT54121 Diploma of Nursing

Course Description

This qualification reflects the role of an enrolled nurse working under the supervision of a registered nurse. This qualification covers the application of skills and knowledge required to provide nursing care for people across the health sector. A lifespan approach should underpin this qualification with relevant competencies that relate to the different stages of life identified within the units.

To be eligible to apply for registration as an enrolled nurse and to practice in Australia, you must complete a Diploma of Nursing program accredited by the Australian Nursing and Midwifery Accreditation Council (ANMAC) and approved as 'an approved program of study' by the Nursing and Midwifery Board of Australia (NMBA) in accordance with the Enrolled Nurse Accreditation Standards.

Enrolment Requirements

To be eligible for enrolment you must:

- 1. Be 18 years of age and provide Photo ID with proof of age.
- 2. Be of Aboriginal or/Torres Strait Islander Descent.
- 3. Be residing in Western Australia.
- 4. Year 12 Western Australia certificate of Education (WACE) or equivalent completion certificate from another Australian State or Territory, passing in maths and science, AND achievement of Exit level 3 in an ACER literacy, language and numeracy test.

If WACE is not obtained, the minimum requirement is attendance and satisfactory completion of at least 6 years of primary and secondary education taught and assessed in English, including at least two (2) years between Years 7 and 12, as specified in the NMBA language skills registration standard.

This course is subsidised by the Department of Training and Workforce Development for Aboriginal and Torres Strait Islander equity groups and jobseekers.

Registration Information

Upon successful completion of this qualification, graduates will be eligible for registration with the Australian Health Practitioner Regulation Agency as an Enrolled Nurse and this will incur a fee.

Delivery

The full qualification will be delivered over 18 months, consisting of 10 blocks of face to face at 295 Manning Road, Waterford WA 6152, Marr Mooditj Training. Monday to Friday, 9am – 4pm.

Work Placement

Students will be required to attend 480 hours of work placement during their training.

Course Fees and Charges

This course is Fee Free for 2025:

To be eligible for concession rates, YOU MUST provide evidence of a valid Pensioner Concession Card or Health Care Card or Centrelink Income Statement.

For Country Students: To access travel and accommodation you must be an ABSTUDY approved student. You must provide the ABSTUDY statement to Marr Mooditj Training before any travel and accommodation can be arranged.

Screening Requirements

Students are required to obtain a Working with Children Check card and current Police Clearance to meet the work placement requirements. These screening documents must be completed within the first two weeks of commencing the course. Students must also provide up to date immunisations records before the commencement of any clinical practice. Forms are available from Marr Mooditj Training. Medical clearance from a General Practitioner assessing physical and mental fitness to undertake the HLT54121 Diploma of Nursing studies if required.

Please note that you will be required to meet the fees for these checks, and that Marr Mooditj Training authorised staff will be required to sign the documents so that you may apply for the lower rate as a student.
