# Marr Mooditj Training

## Fees and Charges

- All Marr Mooditj Training places are subsidised by the WA Department of Training and Workforce Development (DTWD) for the target group of Aboriginal and Torres Strait Islander people.
- Targeted fee relief qualifications are capped annually.
- If you are not eligible to be a subsidised student, full-service fee applies. This information is provided in a separate Fees Schedule.
- Fees and charges are calculated according to the WA Department of Training and Workforce Development VET Fees and Charges Policy.

## Concession/Non-concession/Fee Free Eligibility

You are eligible for fee free in 2026 or concession rate:

- If you hold a Pensioner Concession Card or Health Care Card.
- If you work less than 20 hours per week.

If you do not hold the above cards, you may be charged a non-concession rate.

## Payment Options

- No fees are paid in advance to Marr Mooditj Training.
- On enrolment students will take up one of the following payment options.
- Pay by cash or direct debit as you progress with your studies.
- Centrepay deduction using Centrelink direct debit (This is a payment option to be deducted from your Centrelink payment with your written consent).
